### Harold McElhinny IP Law and the Importance of Dry Martini's

Harold served as the lead trial counsel during the 2012 *Apple v. Samsung* case venued in the U.S. Federal Court, Northern District. He was able to secure a \$290 million dollar verdict on retrial, bringing total damages awarded to Apple in the amount of \$930 million. On March 21, 2016, the U.S. Supreme Court announced that it will hear the appeal case. This is the first time the U.S. Supreme Court has taken up a patent case since the 1800's. In 2014, he defended Target Stores in connection with its data breach. He was inducted into the American College of Trial Lawyers as a fellow in 2007.

### Allison Margolin A History of Marijuana Law

A graduate from Harvard Law and Columbia University, Allison practices criminal defense and civil litigation in the Los Angeles area. She is a frequent writer on the topics on the drug war, search and seizure law and has appeared as an expert regarding internet privacy law and medical marijuana law. She has appeared on the cover of California Lawyer Magazine, the Los Angeles Times and the Los Angeles Daily Journal. She also lectures on the legal issues encountered in California for various bar associations, CEB and public defender offices. She is affectionately known as L.A.'s Dopest Lawyer.

# <u>Justice Mark Simons</u> Electronic Evidence Admissibility: Proper Foundation and Hearsay Issues

Justice Simons was appointed to the First District Court of Appeal in 2001 after serving 20 years as a Judge in Contra Costa. He has served as the Dean of the B.E. Witkin Judicial College where he currently teaches evidence to new judges. In 2000 and 2010, he received the Bernard Jefferson Award for Excellence in Judicial Education from the California Judges Association. In 2014, he was a co-recipient (with Justice Corrigan) of the first annual Distinguished Service Award in Judicial Education from the California Judicial Council.

# Prof. Albert Lin Criminal Law/Crawford Issues - Sixth Amendment Right to Confront Witnesses

Prof. Lin, a Professor of Law at UCD School of Law, was recently interviewed on Capital Public Radio pertaining to his insights on Judge Merrick Garland's nomination to the U.S. Supreme Court as he once clerked for Judge Garland at the U.S. Court of Appeals for the D.C. Circuit. He is also a visiting scholar, ICADE Faculty of Law, Universidad Pontificia Comillas, Madrid Spain. His

background includes working for the U.S. DOJ, Environment & National Resources Division as a trial attorney, earning a Special Achievement Award. In addition to clerking for Judge Garland, he also clerked for Hon. James Browning, U.S. Court of Appeals for the Ninth Circuit. He earned numerous awards while attending U.C. Berkeley, Boalt Hall School of Law, and has written articles and book chapters in addition to 3 books on Environmental Policy. He has also been a speaker and presenter for numerous conferences. He is admitted to practice law in both California and the District of Columbia.
