### **Speaker Information**

Court Evidence presented by the **Hon. Mark Curry**, Placer County Superior Court - Prior to an appointment to the bench for Placer County Superior Court by Gov. Schwarzenegger in 2007, Judge Curry worked for the Sacramento County District Attorney's office from 1986-2007.

Family Law Case Update presented by **Thomas Woodruff** - Mr. Woodruff is a CFLS and was President and on the board of the Association of Certified Family Law Specialists as well as participating on the Executive Committee of the State Bar's Family Law Section. He has lectured in the area of family law for the ABA, CEB and for the PCBA in 2018. He is a partner with Woodruff, O'Hair, Posner and Salinger in Sacramento.

Contracts Breakout Session presented by **Russell Austin** and **Michael O'Neil** - Mr. Austin is a founding partner of Murphy Austin Adams & Schenfeld in Sacramento.
